R&R well, surging well w/air, mist & foamer for approx. 16 days, cleaning out to TD. COOH. RIH w/5-1/2" 15.5#, J-55 casing (liner) and set @ 3348' w/hanger top set @ 3127'. 17' overlap into 7" casing. COOH. RU Blue Jet & perforated liner @ 4 spf .75" holes - 3157'-60'; 3215'-17'; 3233'-36'; 3272'-83'; 3313'-39'; Total 45' = 180 holes. RD Blue Jet.

RIH w/2-3/8", 4.7# tubing and C/O to PBTD @ 3348'. PU & set tubing @ 3318' w/"F" nipple set @ 3286'. ND BOP, NU WH. Pumped off expendable check. RD & releasd rig 11/5/02. Turned well over to production to first deliver.
