Spotted 200 gallons MCA on bottom. Perforated with two shots per foot 2405-2436. Sand-water fracked with 24,900 gallons water and 40,000 pounds sand. Breakdown pressure 1000-500 psi, maximum treating pressure 2025 psi, minimum treating pressure 1700 psi, average treating pressure 1800 psi, average injection rate 43 barrels per minute. Landed 1-1/4" tubing at 2415. Released rig on September 9, 1959. Completed as shut in gas well Blanco Pictured Cliffs Field September 9, 1959. Preliminary test 5369 MCFPD.

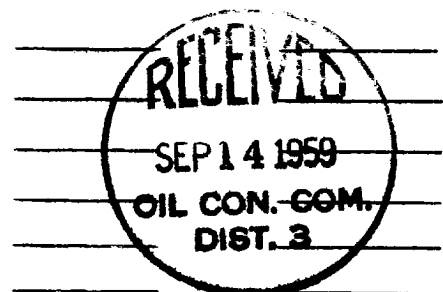
