1. Clean out to TD @ 1936'. Set bottom plug 1936'-1455'.
2. Attempt to pull 7" casing.
3. Set 100' plug at casing stub.
4. Set 100' plug separating the Fruitland and Farmington Formations @ 850'-950' in and out of casing.
5. Set 200' plug across Ojo Alamo formation @ 473'-673' in and out of casing.
6. Set 20 sack plug at the surface.
7. Set dry hole monument.
8. Clean and restore location.
