On 11-26-69 F.B.T.D. 2360'. Perf. 2216-24', 2234-40', 2264-74' w/24 SPZ. Frac w/32,000 10/20 sand, 30,900 gal. water, dropped 2 sets of 24 balls, flushed w/600 gal. water.

Instructions
