DETAILS OF WORK

Plugged and abandoned subject well as follows:

1. Mix 25 sz cement, spot through tbg and squeeze off Dakota formation w/1000 PSI. Left S.I. 3 hrs.
2. Shot off 4-1/2" casing at 3164 and set 15 sz cement plug at top of stub.
3. Set 25 sz cement plug across Pictured Cliff formation from 1168' to 1287'.
4. Set 10 sz cement plug at top of surface casing and set 4" pipe marker in 6' of cement and 4' above ground level.

Work was performed by Bedford, Inc. Job completed 4-10-62.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
