Dear Sir:

This is to inform you that El Paso Natural Gas Company intends to dual complete our Ludwick #11 Well located in the NE/4 of Section 19, Township 30 North, Range 10 West, San Juan County, New Mexico.

This well is to be dually completed in the Pictured Cliffs formation and the Mesa Verde formation. This well is within the bounds of the Blanco Mesa Verde and the Aztec Pictured Cliffs Pools. The dual completion will be a normal tubing annulus completion with a packer separating the production zones and a side door valve installed on the tubing for Bottom Hole Pressures. Upon completion of the well and running of Initial Potential and packer leakage tests, we will request administrative approval from the Oil Conservation Commission.
