PETITION FOR SUBSTITUTION OF BOND

Comes now John J. Moya, and petitions the Commission as follows:

1. That your petitioner, John J. Moya, is a resident of Farmington, New Mexico, and that his Post Office address is 507 North Behrend Avenue, Farmington, New Mexico.
2. That Harmon Owen, former owner and holder of oil and gas leases covering all of the land situate in the SE $\frac{1}{4}$ of Sec. 7, Twp. 30 N., R. 11 W., N.M.P.M., assigned the same to John J. Moya.
3. That your petitioner herein has filed with the Oil and Gas Conservation Commission of the State of New Mexico, a drilling bond written by The Fidelity & Casualty Company, being bond No. 2263540.
4. That your petitioner herein assumed all and singular the obligations of the oil and gas leases covering the whole of said hereinabove described land; and that the above mentioned bond filed by your applicant herein with the Oil and Gas Conservation Commission is filed to replace and take the place of the bond heretofore filed by Harmon Owen with the Oil and Gas Conservation Commission, and under which said bond filed by Harmon Owen the well on the said above described subdivision of land was commenced and drilled to the present depth of said well.
5. That your petitioner herein assumed and agreed to all of the obligations imposed upon him under said leases and assumes and agrees to all of the obligations imposed upon him under the laws, rules and regulations of the State of New Mexico pertaining to the drilling of oil and gas wells in New Mexico.

Wherefore your petitioner prays that the bond heretofore filed by Harmon Owen be released of all obligations relative to the well commenced and drilled on the SE $\frac{1}{4}$, Sec. 7, Twp. 30 N., R. 11 W., N.M.P.M., and that the bond heretofore filed by your applicant be substituted for said bond filed by said Harmon Owen.






