1. *Phylogenetic relationships*—The phylogenetic relationships among the 10 species of *Phrynosoma* were determined using the parsimony method of Felsenstein (1985) as implemented in the computer program PHYLIS (Felsenstein, 1988). The parsimony method was chosen because of its ability to handle large data sets and its relative simplicity. The parsimony method was used to determine the most parsimonious tree (MPT) for the 10 species of *Phrynosoma*. The MPT was determined by using the computer program PHYLIS to generate all possible trees for the 10 species of *Phrynosoma* and then selecting the tree with the fewest steps.
