- 1. The <u>Yager Peel Unit #2 Well</u>, located 1090 feet from the North line and 1090 feet from the West line of Section 6, Township 30 North, Range 11 West, was completed as a gas well on September 30, 1953, and connected to El Paso Natural Gas Company's gathering system November 15, 1953.
- 2. That the proposed non-standard gas proration unit consists of 328.17 acres which are contiguous quarter-quarter sections and lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a single government section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
