This is a well we added the Lewis Shale to the existing MV zone and have flow tested the LS since then. We have now removed the CIBP between the intervals and are producing from all MV intervals. Details below:

10/2/00 MIRU Key Energy #40. ND WH & NU BOP. COOH w/2-3/8" tubing. Made scraper run to to 5150'. C/O fill to 5200' (CIBP). Drilled out CIBP then continued to C/O to PBTD @ 5738'. P/B & landed tubing @ 5688' with "F" nipple set @ 5656'. ND BOP & NU WH. Pumped off expendable check and RD & released rig. Turned well over to production department.
