We propose to drill with Rotary Tools employing mud through Pictured Cliffs and gas drill to estimated TD 6050'.

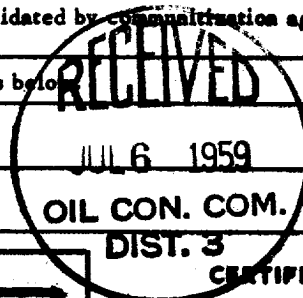

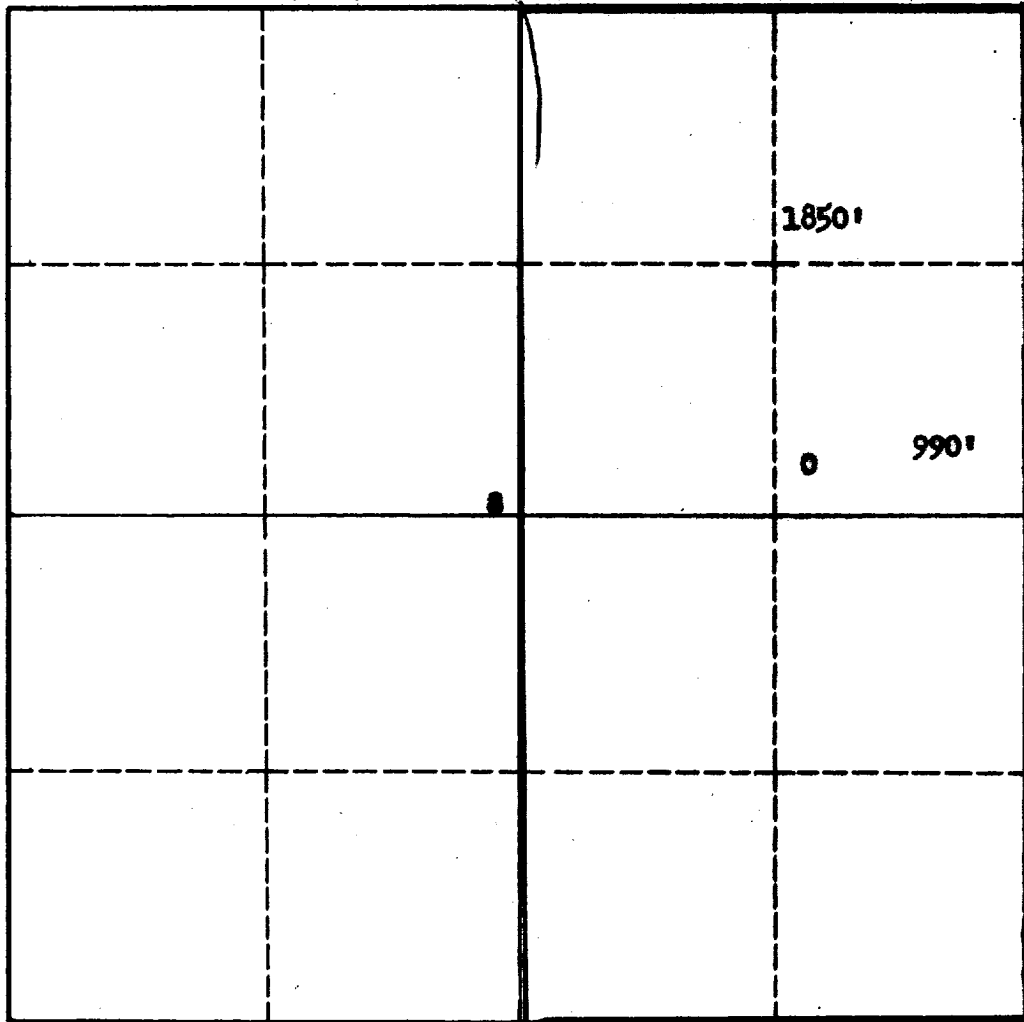
