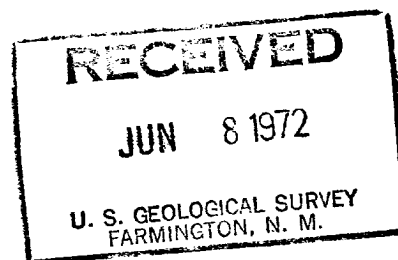

The 12-1/4" hole was spudded May 31, 1972. The 9-5/8" casing was set at 217' and cemented with 200 sacks Class "A" Neat cement with 2% CaCl₂. The cement circulated. The hole was reduced to 7-7/8" at 217' and drilling continued.

The 4-1/2" casing was set at 2930' with 650 sacks 50-50 Poz, Class "C" with 6% Gel and 2 pounds Tuf Plug per sack followed by 100 sacks Class "C" Neat. The cement circulated.

Instructions
