Spud a 12-1/4" hole 7-31-76 and drilled to 260'. Set 9-5/8" casing at 260' with 280 sacks Class "B" cement on 7-31-76. Circulated good cement. WOC and tested blowout preventer, manifold and casing to 800 psi 15 minutes OK. Reduced hole to 8-3/4" and continued drilling to 3230'. Set 7" casing at 3230' with 720 sacks Class "B" cement followed by 30 sacks Class "B" Neat cement on 8-5-76. The cement did not circulate. WOC.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
