Completion operations commenced again on 11-10-81. Total depth of the well is 1942' and the plug back depth is 1894'. Perforated intervals from 1597'-1607' with 2 SPF, a total of 20 .38" holes. Fraced the formation with 18,000 gallons of frac fluid and 24,000 pounds of 20-40 sand. Landed 2-3/8" tubing at 1618'. Released the rig on 11-14-81.
