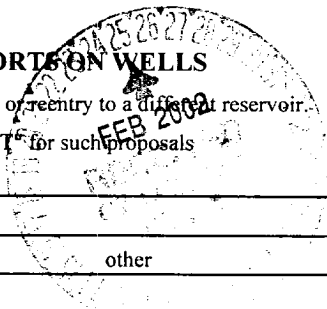

Re-cavitation operations commenced on 1-14-02 and ended on 2-1-02. Pressure tested 7" casing before operations began. The 5-1/2" uncemented per-perforated liner was installed. Top of liner hanger at 3116' KB. Bottom of liner bit shoe at 3384' KB. 2-3/8" tubing set at 3360' KB.
