Vastar elected to reperforate and refrac the Fruitland Coal in the subject well in an attempt to increase gas flow rates. Reperforated Fruitland Coal fm 3812' to 3831 and 3840' to 3842", (Total 21) w/ 4 spf adding 84 holes w/ 0.42" diameter and treated all perfs w/ 500 gal 10 % formic acid followed w/ 90,770 gal 25# / 20#Delta frac 140 gel w/ sandwedge containing 1,730 sx 20/40 Brady sand. After cleaning out the 5 1/2" csg to 3899' (PBDT). Ran a 1.9", 2.76#, J-55, 10RD IJ tbg assembly w/ a profile nipple and WL Re-entry guide. No pkr, EOT at 3802'. Flow and cleaned well to a flowback tank. Will return well to production after clean up. Operations started on 06/16/2000 and were completed on 06/29/2000.
