WILLIAMS PRODUCTION COMPANY proposes to drill a vertical well to develop the Mesa Verde formation at the above described site in accordance with the attached drilling and surface use programs. DRILLING OPERATIONS AUTHORIZED ARE SUBJECT TO COMPLIANCE WITH ATTACHED "GENERAL REQUIREMENTS".

This location has been archaeologically surveyed by CRMC. Copies of the report will be submitted directly to your office.

This APD also is serving as an application to obtain BLM road and pipeline right-of-way. The well will be accessed by a new road approximately 700' long which crosses the NE/SW of Section 35 T32N, R6W where it connects with an existing road. The existing road crosses the NE/SW, NW/SE, and SE/SE of Section 35, the W/2 and N/2 NE/4 of Section 36, T32N, R6W, NW/NW of Section 31, W/2 W/2 and SE/SW of Section 32, T32N, R5W, NW/SE and NE/SE of Section 5, and SW/SW of Section 4, T31N, R5W where it crosses Blanco Wash and connects with the main Rosa Road. The Rosa Road continues SW for 27 miles where it joins the Sims Mesa Highway.
