DETAILS OF WORK

As a result of Ute Mountain Tribal "A" Well No. 3 ceasing to produce oil in commercial quantities we plugged and abandoned this well on 1-29-62 as follows:

1. Pulled rods and tubing.
2. Spotted 40 sacks Incon cement plug on bottom.
3. Filled hole with fluid.
4. Pumped 25 sacks Incon cement containing 2% calcium chloride into 5 1/2" - 8 5/8" casing annulus.
5. Removed all surface equipment and spotted 5 sacks for surface plug.
6. Erected abandonment marker and cleaned up location.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

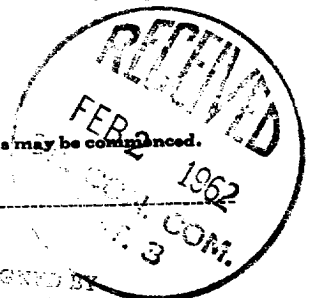
