**Plugging and Abandonment Procedure
Horseshoe Gallup Unit No. 206
Attachment "A"**

WELL DATA:

Location: 1875' FSL, 2010' FWL, Section 35, T31N, R16W
San Juan County, New Mexico

TD: 1510'
PBSD: 1462'

Surface Casing: 8-5/8", 24 ppf, J-55 set @ 95'. Cement w/ 100 sks cement.

Production Casing: 4-1/2", 9.5 ppf, J-55, set @ 1499'. Cement with 135 sks pozmix.

Perforations: 1422' and 1425', notched.

PROCEDURE:

1. Run in hole with tubing.
2. Mix and pump 21 sacks (24.8 cuft) cement. Spot balanced plug from 1425' - 1275'. Pull up to 1000' and reverse out tubing. WOC for 2 to 3 hours.
3. TIH and tag plug. (Plug must be at least 1322'.) TOH and lay down tubing.
4. Perforate squeeze hole at 145'.
5. Establish circulation down casing, through annulus and out bradenhead.
6. Mix and pump 54 sacks (63.7 cuft) cement down casing, through perforations, into annulus and out through bradenhead. Leave casing and annulus full of cement.
7. Cut off casing and install regulation dry hole marker.
8. Reclaim location as per BLM regulations.
