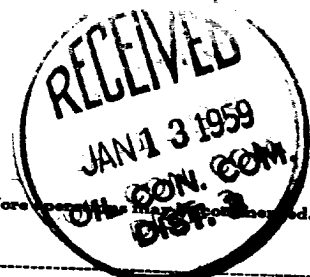

DETAILS OF WORK

Drilled to a total depth of 1321'. Ran Schlumberger SP Sonic log and Induction ES, their T.D. 1322'. Ran 41 joints 4-1/2" O.D. 9.5#, J-55 casing = 1299.05'. Set at 1306.25' and cemented with 150 sacks regular mix Pozmix. Plug down 1:25 A.M., 1-6-59. Ran 4 Baker centralizers. W.O.C. to 1-9-58, 7:00 A.M. Released pressure and tested casing with 1100# for 30 minutes, O.K.
