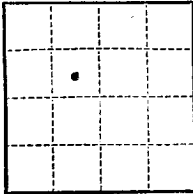

DETAILS OF WORK

This well was spudded 8:30 a.m. 3/4/61. 3 joints of 8 5/8" O.D., 24#, J-55 casing were set at 99.67' and cemented with 110 sacks of common cement plus 2% CaCl. Cement circulated. WOC 18 hours. Tested casing with 600# for 30 minutes. O.K. Drilled 7 7/8" hole to 1770' TD. Set 32 joints of 4 1/2" O.D., 9.5# J-55 casing at 1646.39' and cemented with 150 sacks of regular poxmix. WOC 30 hours. Tested 4 1/2" casing with 1100#. O.K.

Cut two notches at 1568' and 1571' GR with Dowell abrasijet tool. Treated above notches with 250 gals mud acid, 50,000# 10/20 sand and 29,730 gals of lease crude. FPD 1100#. Minimum treating pressure 850#. Maximum treating pressure 1100#. Average rate 37 BPM.
