

DETAILS OF WORK

This well was spudded 5:00 A.M., 10-24-58. Drilled to 105' S.L. Ran 3 joints 8-5/8" O.D. 2 1/2" 3-55 casing = 93.50'. Set at 101.50' and cemented with 125 sacks cement plus 3% CaCl. Plug down 10:00 A.M., 10-24-58. Cement circulated. W.O.C. 18 hours. Tested casing with 600' for 30 minutes, O.K. Drilled plug 4:00 A.M., 10-25-58.
