Spot 375' cement plug from 3145' TD to 2770' (50' above top of Gallup formation).

Spot 100' cement plug from 1850' to 1750' inside 5 1/2" casing across top of Mancos formation at 1800'.

Perforate 5 1/2" casing at 170'. Establish circulation to surface through 5 1/2" by 8 5/8" annulus. Circulate cement to surface.

~~Spot a 50' cement plug from 50' to surface inside 5 1/2" casing.~~

9.5 #/gallon or heavier fresh gel mud between plugs.

Operator will cut off casings below ground level--Weld a 1/4" steel plate across 8 5/8" casing--Erect P&A marker--Clean and restore surface.

Restoration and seeding requirements will be completed when program is recieved from Bureau of Land Management or Ute Mountain Tribal Indian Agency.
