Well Location and Acreage Dedication Plat

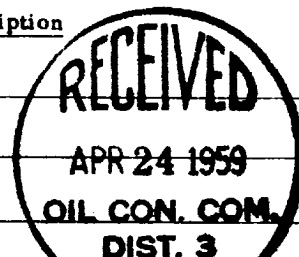

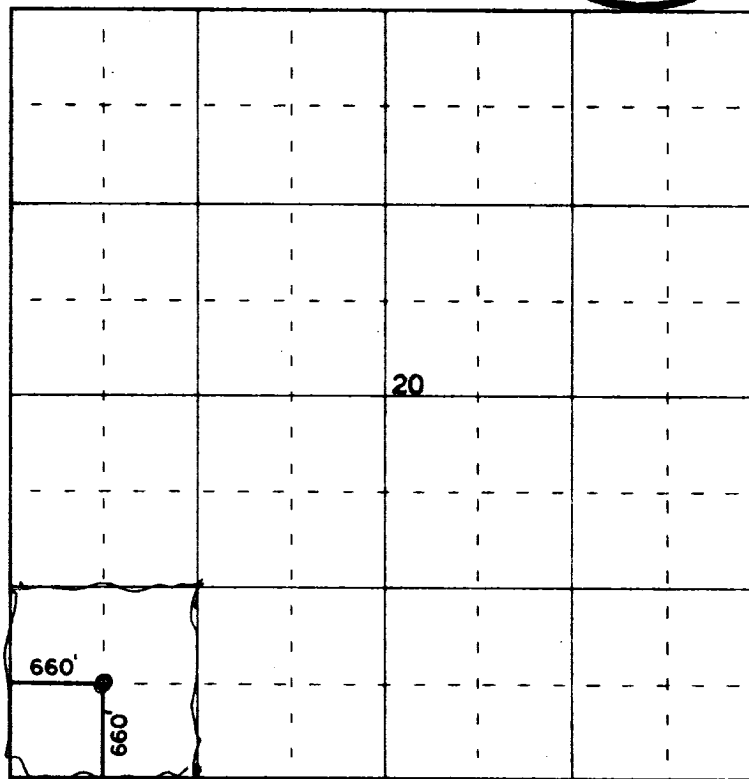
