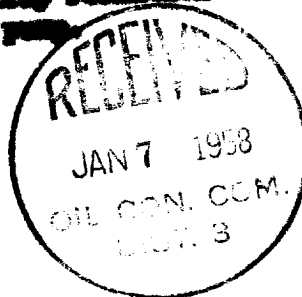

We propose to: Set 120' 9-5/8" casing at 100' with 100 sacks. Drill with Cable Tools to approximately 2400'. Set 5 1/2" casing at 2400' with 125 sacks. Perforate casing formation. Shut oil flow. Run 2-1/8" tubing and install pump.

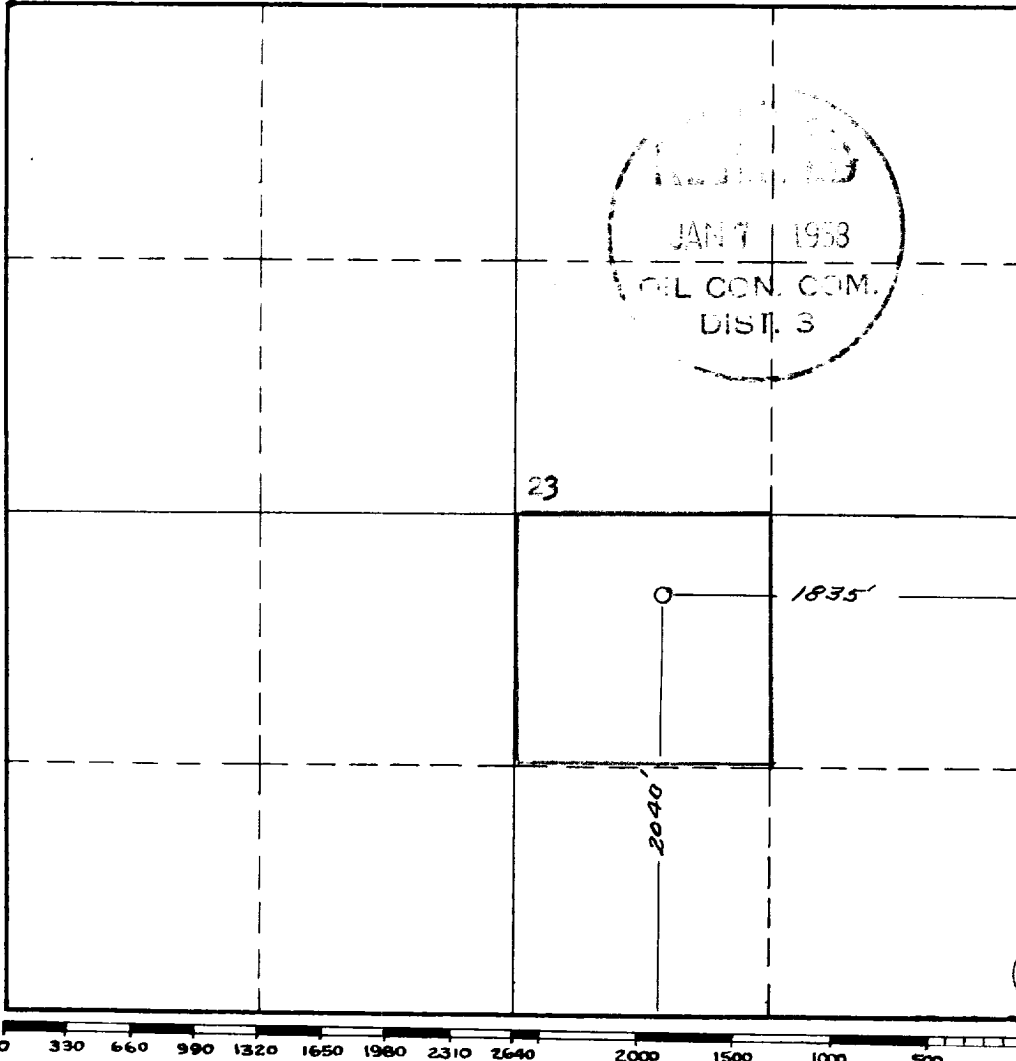
