DETAILS OF WORK

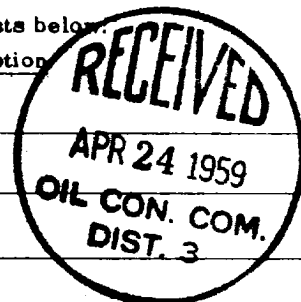

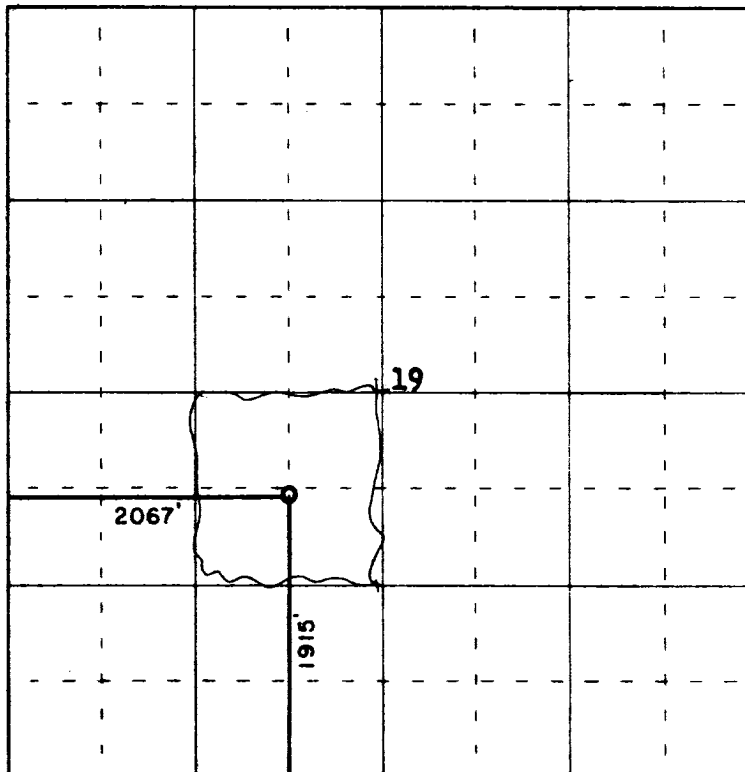
