The above well was plugged and abandoned as follows:

1. Set 24 sack cement plug across open hole section and up into 5-1/2" casing to 2700'.
2. Filled casing with mud.
3. Shot off and pulled 5-1/2" casing at lowest free point - 1350'.
4. Set 28 sack cement plug across casing stub 1300'-1400'.
5. Set 14 sack cement plug across bottom of surface casing 90'-140'.
6. Set 10 sack cement plug in top of surface casing.
7. Erected regulation dry hole marker and cleaned location.
8. Well plugged and abandoned 12-14-66.
