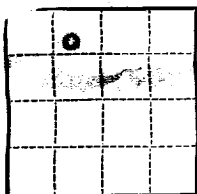

DETAILS OF WORK

It is proposed to pull casing and plug the subject well. A 30-inch plug will be set covering the open hole and approximately 30' of casing. A 30-inch plug will be set covering the stub on the cut-off portion of the pipe. A 15-inch plug will be set covering the end of the surface casing. A 5-inch plug will be set on surface for a monument. In the event we are unable to pull any casing the casing will be filled with mud from the bottom plug to the surface plug. Cement will be pumped down the annulus between the surface pipe and production pipe to prevent surface water encroachment.

The production from this well is now zero.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
