Plug well as follows:

Spot 390' cement plug from 2760' TD to 2370' (50' above top of Gallup formation).

Spot 100' cement plug from 1430' to 1330' inside 5 1/2" casing across top of Mancos formation at 1380'.

Perforate 5 1/2" casing at 155'. Establish circulation to surface through 5 1/2" by 8 5/8" annulus. Circulate cement to surface.

Spot a 50' cement plug from 50' to surface inside 5 1/2" casing.

9.5 #/gallon or heavier fresh gel mud between plugs.

Operator will cut off casings below ground level--Weld a 1/4" steel plate across 8 5/8" casing--Erect P&A marker--Clean and restore surface.

Restoration and seeding requirements will be completed when program is received from Bureau of Land Management or Ute Mountain Tribal Indian Agency.

GENERAL INSTRUCTIONS

This form is designed for submitting proposals to perform certain well operations, and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

SPECIFIC INSTRUCTIONS

Item 4—If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 13—Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
