

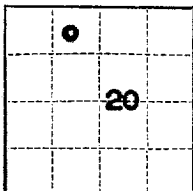

DETAILS OF WORK

We Propose to: Set 100' 13-3/8" surface casing at 100' with 100 sacks. Drill to approximately 2750'. Set 5 1/2" casing at 2750' with 125 sacks, run DV tool below Point Lookout and cement Point Lookout with 200 sacks. Perforate Gallup formation. Sand oil free. Run 2-3/8" tubing and install pump.

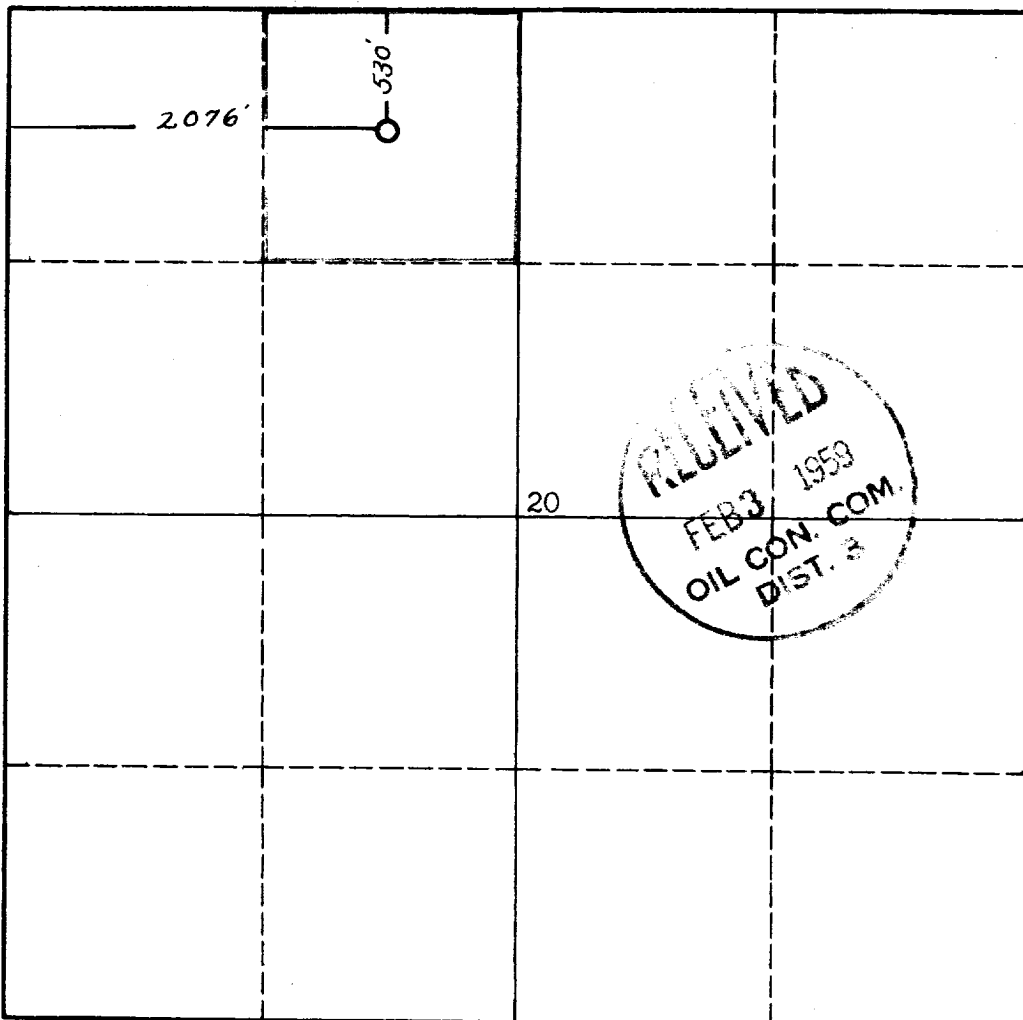
