DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was drilled to a total depth of 4950 feet with rotary tools. Shot formation from 4232 to 4950 feet open with 1900 quarts Hercules slow detonating explosive. Well was cleaned out to total depth with gas and 2" tubing landed at 4919 feet. Well was shut-in eight days. Shut-in casing pressure was 1066 psi. Three hour potential test 4267 MCFPD, January 22, 1954.
