DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On January 6, 1954, 7" casing was landed at 4178 feet and cemented with 150 sacks of cement. Plug down at 2:14 A.M., January 7, 1954. At 11:00 P.M., January 8, 1954, casing and water shut-off were tested at 1000 pounds pump pressure for 30 minutes. No drop in pressure. Forty-five feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 1000 pounds for 30 minutes. No drop in pressure. Drilling operations were resumed.
