A temperature survey was ran on this well and a hole in the tubing was located at 2035'. An Otis type "F" tubing patch was set at 2025' to 2050'. This patch has a 21' piece of 3/4" tubing as a spacer.

This patch is holding and has stopped the tubing leak and communications between the two zones.

Instructions
