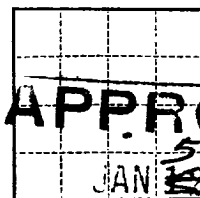

DETAILS OF WORK

Using rotary tools, set approximately 120' of 8-5/8" OD, 24#, J-55 surface casing. Circulate cement, WOC & test for water shut-off. Drill 7-7/8" hole to approximately 2360', run electric log and set 3-1/2" OD, 14#, J-55 Casing on top of Gallup. Cement casing using two stage method, run temp. survey, WOC, test for water shut-off. Drill 4-3/4" hole using crude oil as circulating medium to approximately 2464', test and determine whether or not to frack.



I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

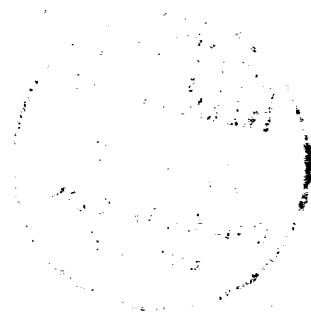

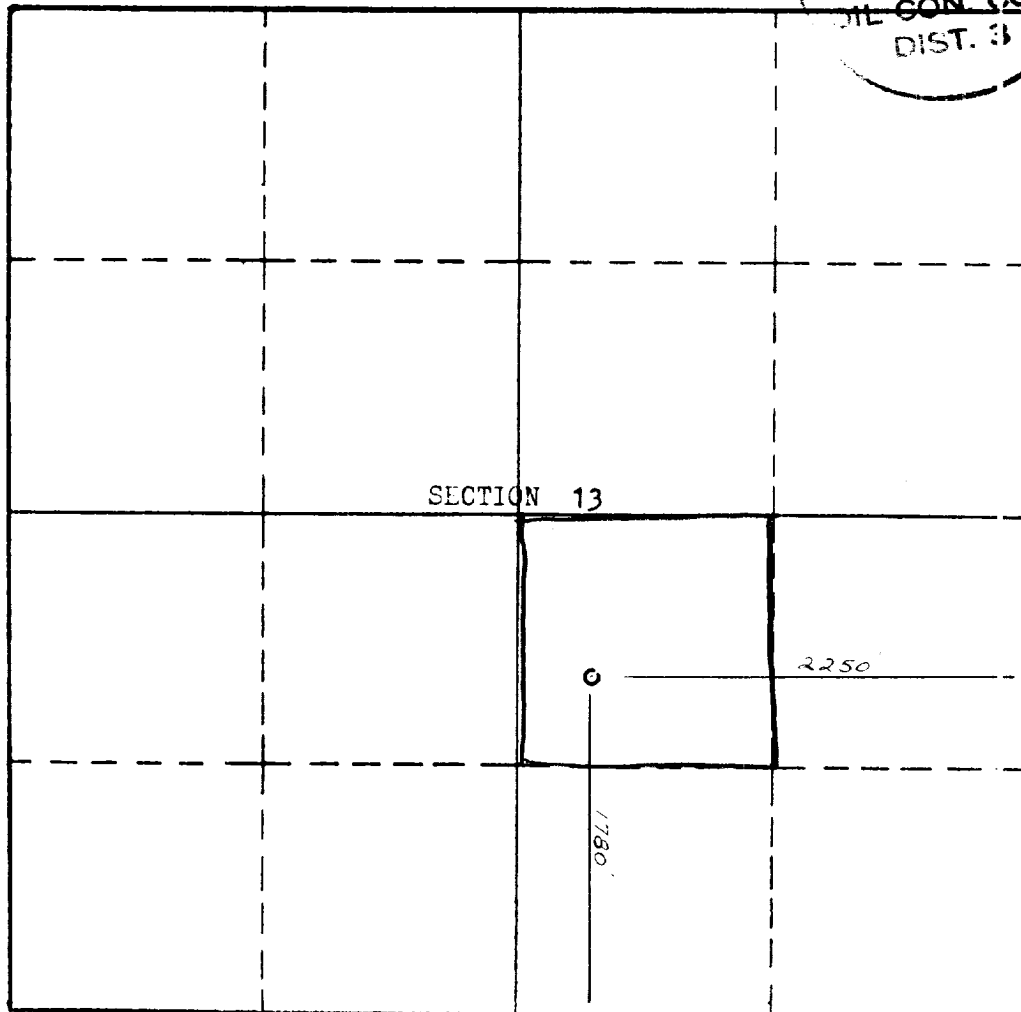
