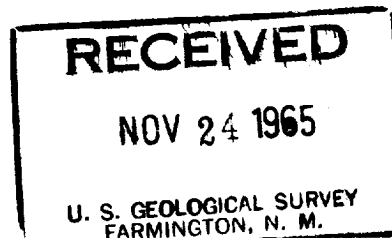

Frac Point Lockout, would not break down, spotted 500 gallons 7 1/2% regular acid. Fraced w/46,000 gallons water, 1 1/2% FR-8/1000 gallons, 45,000# 20/40 sand. MFP 800#, tr pr 1900-2200-2400#. Dropped 3 sets of 16 balls each & 1 of 32. Injection rate 66 BPM. Seated wiper plug in baffle at 4733', tested w/3000#, O.K. Perforated Cliff House 4552-60 w/2, 4518-22' w/4, 4500-08', 4388-96' w/2 MCF sh/ft. Fraced w/39,1000 gallons water 1 1/2% FR-8/1000 gallons., 40,000# 20/40 sand. No breakdown, treating pressure 2500-2600-3200#. Dropped 2 sets of 16 balls each. Injection rate 46 BPM. 5 min SIP 450#.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
