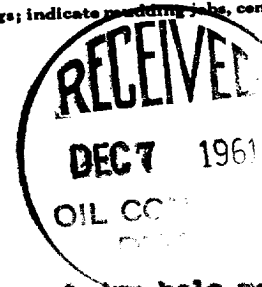

DETAILS OF WORK

This well was plugged & abandoned in the following manner:

1. Spotted a 70 sack cement plug from 7145-7500'.
2. Cut 7" casing off at 2827' and pulled.
3. Cut 9 5/8" casing off at 550' and pulled.
4. Spotted a 75 sack cement plug at 880'.
5. Spotted a 50 sack cement plug at surface w/4' x 4" permanent dry hole marker.
