Top of cement 4000'.

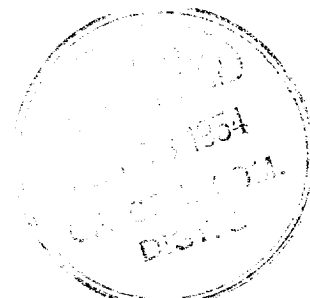
