5. 5 sack cement plug at surface with 4" marker.

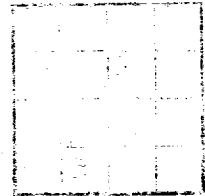

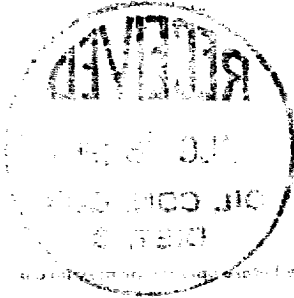
