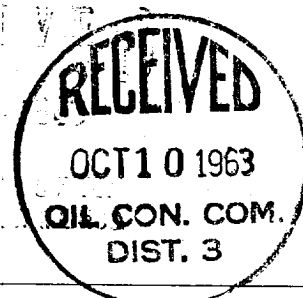

This well was drilled to a total depth of 1800' w/air. No fluid was encountered. We propose to plug and abandon the well in the following manner. Hole size is 3-5/4". Spot cement plug from 1800' SD to 1500' w/about 60 ex cement. Fill hole with gel drilling mud. Put cement plug in top 20' of 3-5/8" surface casing. Put in dry hole marker and clean up location. This procedure was approved by Dr. J. J. McGrath with the U.S.G.S. on 10-8-63.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
