Treated well with 1,000 gallons of Dowell P-121 paraffin solvent, no pressure, and displaced to perforations with 10 barrels of oil. Waited 24 hours and pumped in 1,500 gallons of regular 15% acid, no pressure, and displaced to perforations with 3 barrels of oil. Tested at rate of 65 BO and 110 BWPD. Production prior to job was 55 BO & 106 BWPD. Complete 3-20-70.
