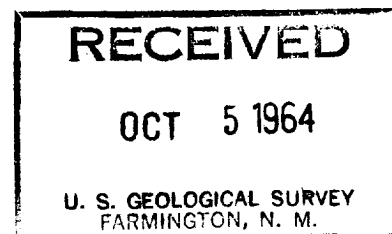
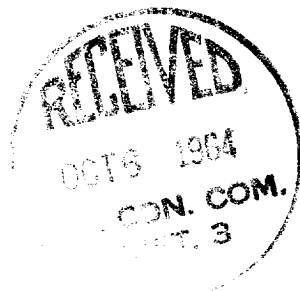

Instructions
