

## Sundry Notice Submittal

Well: Grenier 14  
Unit C, Sec. 7, T31N, R11W

It is intended to recomplete the Mesaverde formation in the existing Dakota wellbore. A rig will MIRU, ND wellhead, NU BOP, and pull production tubing. A CIBP will be set above the Dakota formation at approximately 7296'.

If adequately isolated by cement, the Mesaverde formation will be perforated and fracture stimulated in the following interval: 3594-5465'. If cement remediation operations are necessary, Burlington Resources will contact the appropriate regulatory agency for approval prior to work initiation.

After stimulation flowback and clean out, tubing will be landed at approximately 100' above PBTD. The well will then produce commingled production from the Mesaverde and Dakota formations.
