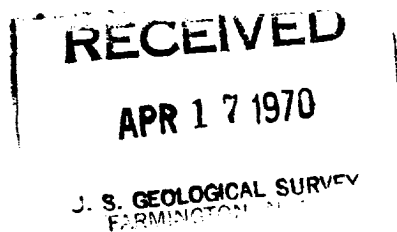

Treated well with 1,000 gallons of Dowell P-121 paraffin solvent, no pressure, and displaced to perforations with 10 barrels of oil. Waited 24 hours and pumped in 1,500 gallons of regular 15% acid, no pressure, and displaced to perforations with 3 barrels of oil. Tested at rate of 29 BO and 160 BWPD. Production prior to job was 18 BO and 50 BWPD. Complete 3-20-70.
