Pumped 1000 gallons Dowell P-121 paraffin solvent down annulus. First 500 gallons in at 1 BPM, no pressure. Pressure increased to 625# when 1000 gallons in annulus. Displaced with 13 barrels of lease crude .3 BPM and 625#. Shut in and let soak for 24 hours.

Pumped 1500 gallons 15% HCl down annulus and displaced with 13 barrels of lease crude. Injection rate of .7 BPM and 775# pressure. Shut in for 30 minutes. Put on pump and tested. Produced at rate of 86 BO and 39 BWPD. Production prior to treatment was 8 BO and 8 BWPD. Job complete 11-5-69.
