

Spudded 8-3/4" surface hole at 1045 PM 7-23-59. Set 7" csg at 35' and cemented w/8 sacks reg cement. Drilled w/air to 1090'. Mudded up and drilled to 1117' TD. Ran logs. Placed cement plug from 962 to 1117' w/25 sacks reg cement, set cement plug from 10' to 0' and install abandonment marker as required by USGS regulations.
