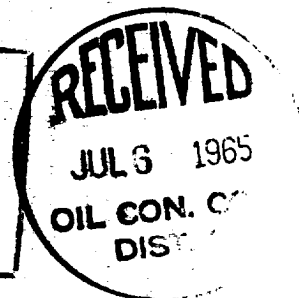
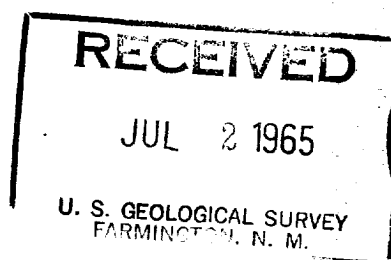

On 6-28-65 ran junk basket to 4617'. Set bridge plug at 4570', tested 7" casing w/1200# O. K. Perf 2 squeeze holes at 2070', set cement retainer at 1876', squeezed w/100 sks. regular cement, 2% calcium chloride, vent on vacuum, cleared perfs w/9 bbls. water. Re-squeezed w/50 sks. regular cement, 2% calcium chloride, 1/4 cu. ft. Gilsomite and 50 sks. regular cement, 2% calcium chloride. Final pressure 400#.

On 6-30-65 cleaned out to 5364', ran 165 joints 4 1/2", 10.5#, J-55 casing (5368.17') set at 5378.17' w/200 sks. regular cement, 2% gel, 1/4 cu. ft. Gilsomite/sk.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
