DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The well was spudded at 3:45 A.M., August 21, 1953. On August 21, 1953, 9-5/8" casing was landed at 271 feet and cemented with 250 sacks of cement. Cement plug down at 4:19 P.M., August 21, 1953. At 4:15 A.M., August 23, 1953, casing and water shut-off were tested at 700 pounds for 30 minutes with no drop in pressure. Forty-three feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 700 pounds for 30 minutes. There was no drop in pressure during this test and drilling operations were resumed.
