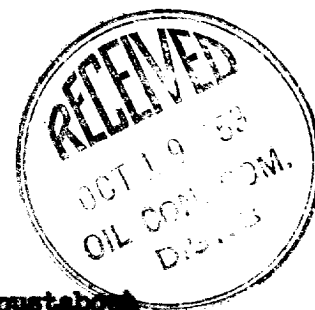

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On September 6, 1953, 7" casing was landed at 4464 feet and cemented with 420 sacks of cement. Plug down at 6:26 P.M., September 6, 1953. At 6:30 P.M., September 8, 1953, casing and water shut-off were tested at 1000 pounds pump pressure for 30 minutes. No drop in pressure. Thirty-eight feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 1000 pounds for 30 minutes. No drop in pressure. Drilling operations were resumed.
