We propose to workover Sammons Gas Unit "A" Well No. 1 as follows:

1. Move in and rig up workover unit and pull tubing.
2. Set drillable bridge plug at approximately 4450'.
3. Load hole with water and test 7" casing to 2500 psi.
4. Run McCullough casing inspection log.
5. Drill out bridge plug and clean out open hole and run 5" liner.
6. Selectively perforate and stimulate Point Lookout and Cliffhouse intervals indicated to be productive.
7. Return well to production.
