DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On April 16, 1954, 7" casing was landed at 4395 feet and cemented with 250 sacks of cement. Plug down at 9:30 P.M., April 16, 1954. At 10:00 P.M., April 18, 1954, casing and water shut-off were tested at 1250 pounds pump pressure for 30 minutes, with no drop in pressure. Forty-five feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 1250 pounds for 30 minutes. There was no drop in pressure during this test and drilling operations were resumed.


